

## **WIND RIVER POOL RULES & REGULATIONS**

2021 Pool Season

### **COVID-19 RULES POSTED AT THE POOL MUST BE OBSERVED.**

- 1. NO LIFEGURDS ARE PROVIDED. POOL IS CLOSED ON MONDAYS. HONOR SYSTEM IN PLACE FOR RULE COMPLIANCE. THESE RULES PLUS THE RULES POSTED AT THE POOL ARE TO BE OBSERVED. PLEASE REPORT ANY PROBLEMS TO COLLINS & ASSOCIATES – (918) 524-3833.**
2. All children under the age of 12 must be accompanied by a parent or guardian. A guardian is required to be at least 16 years of age and responsible for the children at the pool with parental consent.
3. Proper swim wear is required to enter the pool (no un-hemmed cutoffs allowed).
4. Swimming diapers must be worn in the pool by children not toilet trained per health dept.
5. Sunbathers must remove oil and lotion prior to entering the pool.
6. No persons with open wounds, bandages or any symptoms of communicable diseases will be permitted in the pool
7. Running or rough play on the deck, in the pool or in the restrooms is prohibited.
8. No diving allowed.
9. No bouncing hard objects on pool deck.
10. No glass containers or pets allowed in the pool facility.
11. No profanity or abusive language, including loud or inappropriate music, will be tolerated.
12. Spitting, blowing the nose or discharging bodily wastes in the pool is strictly prohibited.
13. NO ALCOHOL ALLOWED. NO SMOKING ALLOWED. Any persons under the influence of alcohol or drugs, creating a scene will not be permitted in the pool facility.
14. Homeowner's dues must be paid in full prior to any resident or their guests using the pool facility.
15. All members have electronic access cards to the pool. Guests can only swim when accompanied by member.
16. Any homeowner bringing a guest to the pool, other than out-of-town guests staying in the homeowner's home must pay a \$2.00 per person fee. Maximum of 5 guests per household per day.
17. Private parties, if allowed, are to be held during designated hours & must be scheduled through management.
18. Any resident or guest who causes damage to the association property will be responsible for the cost of repairs; including any incident which requires the pool to be drained, filled and chemically rebalanced.
19. Wind River Homeowners Association will not be responsible for any lost or stolen items.
20. Use of rafts & flotation devices may be limited or prohibited due to the volume of people using the pool. Use proper judgment and be courteous to your fellow swimmers.
21. No food or drinks allowed in the pool.
22. All trash must be placed in trash containers.
23. Emergency and pool equipment are for emergency use only.
24. Bikes, scooters, skateboards, etc. are not to be left at the pool gate entrance area for safety reasons.
25. All accidents must be reported to management immediately.
26. No swimmer in the water until there has been 30 minutes without thunder or lightning.
27. Golden Rule: Act and treat others at the pool like you want others to act and treat you!
